Ramsay Moodie expressed disquiet and disappointment that we had turned our back on this proposal without any considered review of the pros and cons. Susie Moodie stated our attitude is myopic and that process for decision making was non existent. Dick Austen pointed out that we didn't make any decision. Diane Green stated happy not happening here. Opportunity to consider was lost by hearsay of community antagonism. Tom Kent suggested we send letter to suggest still open to proposal.

Hyde Park Matter-Seamus Casey advised it has resolved itself.

TV Reception- Federal issue Barry Furnell advises he raised with John Cobb. Cobb realises we have been dudded. 'No access to local news' an appeal that will be heard. Barry advised that Win and Prime news available on VAST.

Ramsay tabled tentative financial reports Year Ending June for Western Crossings Trust.

Duncan Wass read from Western Crossings Trust accounts showing total receipts of \$35,239 and total outlays of \$27,826.

Ramsay indicated these were tentative first pass results with some \$7k still on hand to fund printing of Moment in Time book.

Duncan referenced Margaret Combs email quoting 1813 committee has lost its way and supporters abandoning. Duncan denied and in support of denial read list of fifty or more volunteers who had surfaced out of community, responding to appeal in last newsletter to support a Moment in Time etc Chair expressed congratulation on job well done.

Susie Moodie: How do we capture the wave of positive sentiment that flows from 1813 activities? Extraordinary people, fabulous volunteer support overwhelming good positive vibes. Susie expressed thanks to Dick Austen for Coxs Rd access.

Jeremy Dawkins suggested minute list of names and list in newsletter. Seamus Casey as chair expressed vote of thanks for massive effort, such fun. Diane Green commented that champagne breakfast was wonderful thank you function.

Ramsay Moodie stated nothing to report everybody focussed on 1813 delivery.

General Business

Notice of motion from Barry Furnell

'This Association advises the Hon Duncan Gay, Minister for Roads and Maritime Services though Mr. Paul Toole MP that it believes that the overwhelming majority of the local community is strongly opposed to the Final Conceptual Plan proposed for the Great Western Highway upgrade between Brown Town Oval and the top of River Lett Hill.

"Further this Association requests the Minister to arrange for the urgent study and report on all other likely alternatives for this stretch of road."

Barry spoke to motion as attempt to get around log jam and find something that will be done because concept design will never get done.

Ramsay spoke and said first point agreed but would move amendment to second leg as totally contrary to concluded community position unless modified to be 'outside the valley'. Purple corridor reopening was specifically put to last public meeting and 90%plus against.

Barry countered motion not suggesting any particular route.

Tom Kent vehemently opposed to motion as thinly disguised attempt to pursue purple corridor and create another line of road through valley totally contrary to majority public view.

Barry Furnell: Got to find a way for people out west. Mt Vic and River Lett Hill can never be fixed.

Jeremy Dawkins stated community reaction has been an entirely appropriate rejection of an F3 style road. Total over correction when safety enhancement primary need. We have not seen the impact of implementation of Point to Point camera commitment. We should allow freight to find a plateau route.

Dick Austen: John James held 2 or 3 meetings to look for alternate routes. Trish Ryan stated not that committees role to select routes that have been done by public meetings.

Duncan Wass Public meeting process has resolved community position.

Seamus Casev: Awkward

Dick Austen: Don't mean to be offensive but Ramsay Moodie never mentioned safety at MT Vic (6/09) meeting.

Ramsay Objected that is offensive. Safety has always been first priority.

Dick Austen Plateau route has been rejected. River Lett Hill accident rate unacceptable.

Ramsay: But committed point to point cameras not installed yet.

Dick: Road is just as bad as ever

With clear majority against, Barry Furnell chose to withdraw motion stating 'you people don't care if people get killed'. Several objected strongly.

Barry refused to withdraw this statement.

Jeremy Dawkins: HHAG and community have had safety as primary concern since day one.

Roads & Maritime Services has done little to improve safety. The majority of people in this room have always had safety as first priority.

Ramsay commented that point to point technology properly implemented will dramatically improve safety.

Tom Kent moved that HDPA should act to call for point to point camera installation to proceed asap.

Seamus Casey: we will consider at next meeting.

Lynda Lovegrove: Thanks for 1813 great effort. When is fire shed going to have pianos (that had been stored during A Moment in Time Exhibiton) removed? Agreed Wednesday for pianos. Discussed desirability of storing stuff in small shed.

Seamus C to chase Appleseeds to OK clean out.

Seamus C to arrange for pianos to be assessed, one believed to be Hartley Vale School historic item.

Duncan Wass Oral history workshop \$95. Agreed we should pay for two places.

Diane Green interested, Fran Leighton suggested?.
